### **Booking Terms & Conditions**

#### **Payment:**

- A booking deposit of \$100 is required upon receiving the booking request approval in order to secure the timeslot. The remaining balance must be paid on the day of the event before the event begins.
- Credit card payment is subject to 3% credit card processing fee.

#### **Media Copyrights:**

- The client hereby releases image, logo, and title to iBubble Soccer Ltd. for promotional purposes only. The client acknowledges that iBubble Soccer Ltd. may use image, logo, and title for promotional purposes only, without its permission or knowledge. The client also grants permission for iBubble Soccer Ltd. use the image of any of attendees during the rental for promotional purposes only.

#### **Cancellation:**

- Bookings can be cancelled after booking confirmation but the deposit is non-refundable within 7 days of the booking date. We highly encourage the client to ask about our rescheduling opportunity in advance if there is a time conflict.

#### **Weather Conditions:**

- Bubble soccer cannot be played in the rain or on any wet surface, for the safety of players and our equipment. If the weather turns bad on the day of the event, the outdoor event will be cancelled. The client will be given the options to reschedule it to another day for free, or move it to an indoor venue if he/she can supply one.
- If it rains during the rental, the event will be immediately cancelled, and the client will not be provided with any rescheduling opportunity or refunds.
- If our bubbles become dirty or muddy beyond normal conditions, as determined by iBubble Soccer Ltd., the client will be charged a \$30 cleaning fee.

#### **Damage and Loss:**

- The client is responsible for and agrees to indemnify iBubble Soccer Ltd. for any loss of property, damage or expense caused to iBubble Soccer Ltd. and/or its property by guests attending the event.
- The client agrees to pay \$400 for any damages recklessly or intentionally made by the client or their guests, and to cover any additional costs that may be incurred. Caregivers are responsible for minors.

#### **Game Play:**

- The client agrees to indemnify, defend, and hold harmless iBubble Soccer Ltd., and its owners, employees, and contractors from any or all claims and judgments for damages and expenses to which iBubble Soccer Ltd. and its owners, employees, and contractors may be subjected to or which they may suffer or incur by reason of any action by the client or guests, agents, servants or employees during its use of the equipment.
- The use of drugs and alcohol is prohibited during the event.
- All players must sign a waiver form before playing. Minors must have their parents/guardians sign for them.
- Any persons who may be pregnant, suffer from neck, back or heart conditions or have had any prior injuries which may render them more at risk of injury from physical activity are not to participate in any activities.
- No liability can be accepted for lost or damaged personal property such as clothing, watches, cameras, etc.
- iBubble Soccer Ltd. is not responsible for any health or safety concerns. If any harm is incurred from the activity, iBubble Soccer Ltd. shares no responsibility.

#### **Venue:**

- The client asserts that they have the approval from the venue where the rental will take place to have iBubble Soccer Ltd. and is responsible for any costs associated with that.
- The renter also will grant iBubble Soccer Ltd. access to the venue one half hour before and after the rental for set-up and take-down.
